### **POPE RESOURCES ANNOUNCES QUARTERLY DISTRIBUTION**

Pope Resources (NASDAQ:POPE) announced today a quarterly distribution of \$0.55 per unit, effective for unitholders of record on December 2, 2013 and payable on December 18, 2013.

This release is intended to be a qualified notice under Treasury Regulation Section 1.1446-4(b).
